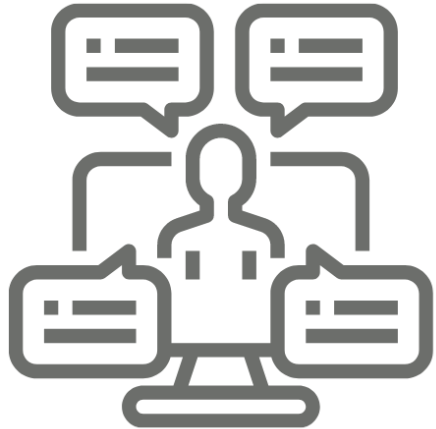

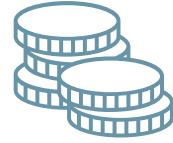



- Initiatives encouraging **active citizenship**, including among youths
- Projects for **community wellbeing** including investment in rural infrastructure and improved service provision to residents
